PERFORMANCE AUTO COLLISION, INC. will accept Personal checks (up to \$3,000), insurance checks, cashiers checks, and or cash for payment on repairs. There will be a \$15.00 fee for all returned checks. If your check is returned to us by the bank for any reason, you have 24 hours to make payment to us by cash or cashier's check or return the vehicle to us until full payment is made. If full payment is not made within 24 hours, Performance Auto Collision, Inc. reserves the right to have your vehicle impounded until such payment has been made.
